This insecticide contains the active ingredient spinosad which is derived from a naturally occurring bacterium, *Saccharopolyspora spinosa*. Ants are attracted by the bait and carry it to their nest where it is fed to other worker ants, larvae and the queen. The colony is controlled within 1 to 2 weeks. Kills ants, including carpenter ants.

## **USE SITES:**

**OUTDOOR AREAS:** ornamental landscaped areas (such as in residential areas and parks), turf (such as lawns, athletic fields, recreational areas, golf courses, commercial turf, sod, grass buffers, parks, playgrounds, cemeteries, picnic areas and campgrounds), crop areas (food and feed), gardens and fallow lands.

**RESIDENTIAL, INSTITUTIONAL, COMMERCIAL, AND INDUSTRIAL AREAS:** Use in and around single and multi-family residential buildings, institutional, commercial and industrial facilities (such as schools, hospitals, warehouses, apartments, supermarkets, restaurants, kitchens, motels, hotels, processing facilities/plants, barns, livestock dwellings, and railyards), on or around decks, patios, balconies, paths, electrical conduits, vents, pipe chases, concrete slabs, crawlspaces, skylights on roofs, garbage cans, around and behind appliances, along walls, window sills, sidewalks, and driveways; on ground around home or structure, and other areas ants are found.

## **DIRECTIONS FOR USE:**

1. For small bait stations (up to 10 mL) place 1.5 to 3 metres apart and use up to 4 bait stations or 40 mL of liquid bait per 15 m<sup>2</sup> if ant infestations are low to moderate. For severe infestations use up to 9 bait stations or 90 mL of liquid ant bait per 15 m<sup>2</sup>. For large bait stations (more than 100 mL) space further apart, up to one every 50 m<sup>2</sup>.
2. Place bait station near ant nest or where ants are visible. Avoid placing in direct sun to decrease evaporation of the bait solution.
3. Fill according to the directions accompanying purchased bait stations.
4. Check station regularly and refill when the bait solution has been consumed or dried out.
5. The bait stations should remain in place to ensure that ant colonies are exterminated.
6. When the ant population has been controlled, the bait station may be cleaned and moved to a different location. Do not reuse the bait station except to refill with liquid ant bait solution.
7. This product may also be applied directly to non-porous paper, plastic, cardboard, or foil and placed beside ant nests or where ants are visible. When applied in this way, DO

NOT use in residential areas. Residential areas are defined as any use site where bystanders, including children, could be exposed during or after application. This includes homes, schools, parks, playgrounds, playing fields, public buildings or any other areas where the general public, including children, could be exposed. Place where inaccessible to children, pets, and non-target animals.

8. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

**PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN, DOMESTIC AND NON-TARGET ANIMALS. TOXICOLOGICAL INFORMATION:** Treat symptomatically.

**FIRST AID:**

**If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
